# "Opioid Induced Respiratory Failure (OIRD): are there early warning signs?" Robert J. Farney, MD, FACCP

Division of Pulmonary Medicine & Sleep/Wake Center, University of Utah

The discussion will be on how opioids suppress all aspects of respiration, including drive and rhythm. Respiratory effects occur mainly during sleep or non-awake states. Dr. Farney will also address the fact that there is a sub-population with enhanced sensitivity and without known risk factors, and will review the background and manifestations of opioid toxicity that occur during sleep.
